PROVIDING FOR THE EXTENSION OF THE CITY LIMITS OF THE CITY OF NEW BERLIN, TEXAS BY THE ANNEXATION OF LAND LOCATED ADJACENT TO THE CITY OF NEW BERLIN, TEXAS CITY.

WHEREAS, the City of New Berlin, Texas has agreed to maintain a portion of Gin Road being more particularly described in Appendix A attached hereto; and

WHEREAS, the City Council of the City of New Berlin, Texas, believing that the above-described property is annexed pursuant to Texas Local Government Code section 43.028, and

WHEREAS, on the 21 day of May, 2007 the City Council of the City of New Berlin, Texas held public hearings on the proposed annexation of land situated outside of, but immediately adjacent to, the current corporate limits of the City of New Berlin, Texas and such public hearings gave all interested persons the right to appear and be heard on the proposed annexation of such land; and

WHEREAS, notice of the above mention public hearings was published in the Seguin Gazette Enterprise on May 11, 2007, a newspaper having general circulation in the City of New Berlin, Texas and within the territory to be annexed, in accordance with law; and

WHEREAS, the aforementioned public hearings were conducted not more that twenty (20) days nor less that ten (10) days prior to the institution of annexation proceedings; and


NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEW BERLIN, TEXAS:

SECTION 1. The land and territory lying outside of, but adjacent to and adjoining the City of New Berlin, Texas, more particularly described as that portion of the tract of land described in Exhibit "A," attached hereto and incorporated herein by reference, is hereby added and annexed to the City of New Berlin, Texas, and said territory, as described, shall hereafter be included within the boundary limits of said City, and the present boundary limits of said City, at the various points contiguous to the area described in Exhibit "A," are altered and amended so as to include said area within the corporate limits of the City of New Berlin, Texas.

SECTION 2. This ordinance shall be effective from and after May 21, 2007.

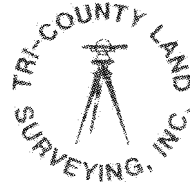

**County Road 404
Gin Road**

Description of a tract of land adjoining the city limits of the City of New Berlin, Guadalupe County, Texas, being a portion of Guadalupe County Road 404 (Gin Road) and being more particularly described as follows:

Beginning at a point at the intersection of the northeast right-of-way line of County Road 315 (S. Santa Clara Road) and the northwest right-of-way line of County Road 404 (Gin Road) for the south corner of a tract of land called 15.00 acres, conveyed to Nelson Schultze and wife Jacquelyn by deed recorded in Volume 531, Page 85, Deed Records, Guadalupe County, Texas and the west corner of the herein described tract.

Thence, in a northeasterly direction with the northwest right-of-way line of County 404 and the southeast line of the Schultze tract to a point for the south corner of a tract of land called 9.50 acres, conveyed to Darryl Ross Surman and wife Betty Jean Surman, by deed recorded in Volume 531, Page 82, Deed Records, Guadalupe County, Texas, for the north corner of the herein described tract.

Thence, in a southeasterly direction, crossing County Road 404, with the extension of the Schultze tract, to a point in the southeast right-of-way line of County Road 404, and the northwest line of a tract of land called 100.56 acres, conveyed to P.F. Flores, Archbishop of San Antonio, by deed recorded in Volume 869, Page 846, Official Records, Guadalupe County, Texas, for the east corner of the here in described tract.

Thence, in a southwesterly direction with the southeast right-of-way line of County Road 404 and the northwest line of the P.F. Flores tract, to a point at the northeast end of the cutback line of County Road 315 into County Road 404, for the south corner of the herein described tract.

Thence, in a northwesterly direction, crossing County Road 404, to the **Place of Beginning**.

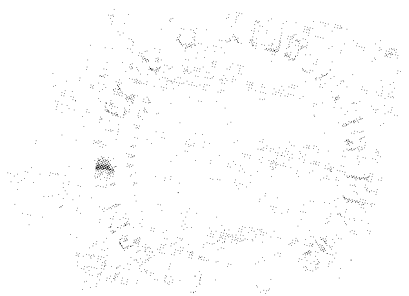

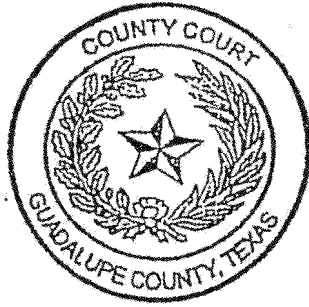
